

VOLUNTARY WAIVER AND RELEASE OF LIABILITY BACKGROUND CHECK AUTHORIZATION

This form is to be read and all persons must agree to the terms, in order to do volunteer work of any type for L-C Valley Habitat for Humanity. I desire to work as a volunteer for L-C Valley Habitat for Humanity. I understand that permission has been granted to me by the Board of L-C Valley Habitat for Humanity to work at the designated work sites. I understand that all volunteer activities, including volunteer work at L-C Valley Habitat for Humanity work sites and other volunteer work for Habitat, involve risk of harm. I am aware of these risks and knowingly and willingly assume all risks of personal injury and loss of personal property that may be sustained in connection with these activities. In consideration of my being permitted to participate in any and all volunteer activities and work for L-C Valley Habitat for Humanity, I hereby waive, release and discharge L-C Valley Habitat for Humanity, all members of its Board of Directors, its officers, employees, and agents, and other volunteers from any and all claims, demands, actions or causes of action of whatever nature which may arise out of my participation in volunteer activities and work for L-C Valley Habitat for Humanity, including, but not limited to, personal injury or property damage, except due to their negligence.

BACKGROUND CHECK APPROVAL

Lastly, I understand that Habitat for Humanity screens all potential volunteers through the national sex offender registry. Key volunteers, staff (whether paid or unpaid), board members and applicant families receive additional screening through Washington State Patrol, and federal law enforcement agencies. I hereby release, discharge and agree to hold harmless HFH, its nominees, designees, successors and assigns, or others for whom they are acting, from any liability of any nature or description by virtue of any use whatsoever, whether intentional or otherwise, from any change that may occur or be produced in the taking of said picture or pictures, in-any processing tending towards the completion of the finished product, unless it can be shown that said use or change is solely for the purpose of subjecting me to conspicuous ridicule, scandal, reproach, scorn and indignity.
